Communication and Relationships

Patient / Client Care

Key Result Areas

- Develops nutrition and/or dietetic treatment care plans for patients in general dietetics.
- Delivers patient education programmes such as cardiac rehabilitation
- Maintains records of patient care and communication with referrer.
- Continuously seeks to improve and develop professional practice within safe parameters.
