

Job Summary

The Plumbers' responsibilities, in support of the Estates Managers, consist of carrying out planned preventative maintenance, reactive repairs, and installation work to plumbing systems; including pipework, water tanks and various sanitary fixtures and fittings, remedial roof repairs and various equipment items as managed by the Estates Department without constant task supervision.

Many of the repairs will need to be attended to urgently and some aspects of the work can be unpleasant and hazardous. The post holder will be expected to partake in a Trust wide on-call system to ensure responsive and effective repairs to systems affecting the end user.

The post holder's duties are expected to liaise closely with the other trade groups, contractors, staff and end users, service providers and manufactures in order to ensure that the Trust receives the highest standard of service efficiently & effectively.

Key Role and Responsibilities

Professional Duties

To carry out Plumbing repairs and Planned Maintenance work, breakdown maintenance and diagnosing faults including a degree of new installation work.

- Repair and renewal of all types of sanitary equipment including washbasins, sinks, WC's, cisterns, slop hoppers etc.
- Maintenance, repair and fault diagnosis of bedpan macerators, dishwashers
- etc.
- Carry out maintenance of complex systems including Heating and DHW systems, pressurised systems, water systems, tanks, rainwater systems, building management systems, plant and equipment contained within the theatres and throughout the hospital and peripheral sites.
- Repair, replacement, and removal of blockages from above ground drainage systems, both internally and externally including guttering, downspouts and building gullies.
- Repair and removal of blockages from below ground drainage systems both internally and externally including road gullies and manholes.
- Repairs and renewal of various other equipment items such as pressurisation units, and other installations concomitant with plumbing duties.
- Maintenance, and repair of the Hydrotherapy pool plant and associated equipment
- Repair work to be conducted in a manner compliant with water safety regulations and using a code of practice in order to control pathogens in the hospital water system.
- Participate in providing 24-hour, 365 day a year via On Call system for the Trust and cover for absent colleagues.

Communications and Relationships

Working alongside the other departments of the Estates and Facilities team plus clinical colleagues across the hospital, you will need to be able to form professional

relationships and communicate with them at all levels in a courteous and professional manner.

You may be required to advise and assist external contractors to enable successful completion of works.

Analytical and Judgmental Skills

The post holder will need to assess working and maintenance situations in order to affect the best and safest solution whilst taking into consideration the impact it will have on the surrounding environment and people including the staff, end users and the Trust as a whole.

You will be numerate, literate and possess basic PC skills.

You will be responsible for maintaining and updating records that may be held on computer databases, CAFM systems, Building Management Systems, paper based etc.

Financial Responsibility

The post holder will be responsible for identifying and advising the Plumbing Supervisor of materials and equipment required to undertake the role, recognising value for money, and providing commercial awareness

Planning and Organisational Skills

You will need to organise, prioritise, and manage the plumbing and maintenance jobs allocated to you both on a day-to-day basis and longer term.

You will be required to read and understand job sheets (paper or electronic) and fill in details on completion

You will need to conduct assessments of the work you attend analysing risk and the impact the work will have on others in the area.

You must be capable of reading and understanding mechanical installation plans, drawings and understand the workings of the plumbing systems within the Trusts buildings.

Ability to work alone, without supervision on a majority of plumbing based works.

Ability to assess and use initiative in resolving plumbing maintenance issues All works to be carried out in accordance and compliance with HTMs - Hospital Technical Memorandums, Water Supply (Water Fittings) Regulations, ACOP L8, Hospital Buildings Notes and Building Regulations

Leadership and Management

You may be required to instruct others in all aspects of plumbing e.g. work experience, other tradesmen (including contractors), deal with new situations / techniques and pass on knowledge to colleagues and apprentices/maintenance assistants.

The job role will involve elements of allocation and monitoring of work efficiencies and effectiveness with assessment, appraisals, and personal development planning. The post holder will be required to attend any training activities that are deemed necessary in order to enable them to conduct their work in a competent manner and to ensure they meet legislative and Trust policy and procedure requirements.

Appendix

The below details all the standard Trust requirements which must be incorporated within the role.

Infection Prevention

Employees will adhere to all Trust Infection Control policies and procedures which are relevant to the post and undertake any appropriate mandatory training. All colleagues will ensure that advice is sought from the infection control team as required and appropriate action is taken to minimise cross infection.

Safeguarding

The Trust is committed to safeguarding and promoting the welfare of children, young people and vulnerable adults and expects all employees and volunteers to share this commitment. You will be expected to fulfil your mandatory safeguarding training at the level applicable to this role.

Health and Safety

Employees must act in accordance with the Health & Safety at Work Act 1974, and subsequent legislation, under which they must take reasonable care to avoid injury to themselves and to others who may be affected by their work activities.

Employees are required to co-operate with the Trust in meeting statutory requirements. Employees must not intentionally or recklessly interfere with, or misuse anything that is provided in the interest of the health, safety and welfare of colleagues, patients, and the general public.

Work in accordance with all Trust policies and procedures.

Ensure the Post Holder attends induction and regular mandatory update training on risk management policy and procedures.

Ensure Post Holder identify through risk assessment, any risks they feel exist within their department or during the delivery of their services.

Ensure Post Holder provides incident reports and supporting documentation for any unexpected event or incident they are involved in.

Ensure the Estates asbestos register is issued/highlighted to all colleagues, including, MTC Contractors and Capital Design Contractors etc.

As with any employment, you will be subject to health and safety provisions covering all aspects of your work.

- PUWER Provision and use of Working Equipment Regulations,
- Workplace Health Safety & Welfare Regulations.

Additionally you will be subject to the NHS Estates guidance known as Health Technical Memoranda and Health Building Notes.

You have a personal responsibility to support your department in reducing hospital acquired infection. You must comply with the Trust's policies on infection, prevention and control and maintain your competency to effectively discharge your responsibilities. You must bring deficiencies to the attention of your manager.

As well as the general duty of care, the post holder will need to respond to any specific issues relating to staff or the public regarding health & safety and any hazards associated in the normal course of the role.

Confidentiality and Data Protection

Employees are required to uphold the confidentiality of all records held by the Trust, whether patient records or Trust information. Unauthorised disclosure of any confidential information, or that covered by the Data Protection Act may result in disciplinary action.

Equality and Diversity

All colleagues are required to understand the equality and diversity commitments and statutory obligations under the Equality Act 2010. You must act in ways that support Equality, Diversity, and Inclusion (EDI) and recognise the importance of people's rights in accordance with legislation, policies, frameworks, procedures, and good practice.

Colleagues must recognise and report any behaviour that undermines equality under Trust policy and further EDI activity by:
