2. Overview of the Post

We are seeking to recruit a highly specialist clinical psychologist. The successful candidate will join the psychological therapies team within the Bexley ICMP Team, and will be offering highly specialised psychological assessment and intervention to service users referred to the Oxleas psychosis pathway, consistent with NICE approved treatments. The post holder will offer advice and consultation on clients' psychological care to non-psychologist colleagues and to other, non-professional carers.

The post holder will supervise trainee Doctoral clinical psychologists, implement low level CBT interventions through non psychology team members and work autonomously within professional guidelines and the overall framework of the team's policies and procedures.

The post holder will utilize research skills for audit, policy and service development, and to conduct research within the area served by the team/service. To work assertively to engage clients and promote social inclusion and recovery, and to participate in early detection or relapse and community family and friends education work.

The Oxleas Psychosis Pathway Includes the Early Intervention Team (EIP) and Intense Case Management for Psychosis Team (ICMP). It is a borough wide service and both teams are based at the Erith Center. They consist of a multidisciplinary team of professionals, including consultant psychiatrists, specialist adult metal health nurses, clinical/counselling psychologists, CBT therapists, employment support workers, lived experience practitioners and occupational therapists. We offer a community service for working age adults with severe and complex mental health difficulties. The team has close links with other services, including third sector organizations. We work collaboratively with other services. Oxleas has a strong tradition in promoting psychological therapies and embraces multi-modal formulation-based approaches. Personal therapeutic interests and specialty development are actively encouraged and supported. This can be via formal training as well as established specialist supervision forums which are provided across the Trust.

There will be the opportunity to develop specialist competencies in evidence-based models (eg CBT,EMDR and Family Intervention) for individual and group therapy.

- To provide specialist psychological assessments of clients referred to the ICMP Mental Health Service based upon the appropriate use, interpretation, and integration of complex psychological data from a variety of sources including psychological and neuropsychological tests, self-report measures, rating scales, direct and indirect structured observations and semi-structured interviews with clients, family members and others involved in the client's care.
- To formulate and implement plans for the formal psychological treatment

and/or management of a client's mental health problems, based upon an appropriate conceptual framework of the client's problems, and employing methods of proven efficacy, across the full range of care settings.

- To be responsible for implementing a range of psychological interventions for individuals, carers, families and groups, within and across teams employed individually and in synthesis, adjusting and refining psychological formulations drawing upon different explanatory models and maintaining a number of provisional hypotheses.
- To deliver NICE approved CBTp and Family Interventions for Psychosis.
- To facilitate groups for clients and carers
- To evaluate and make decisions about treatment options taking into account both theoretical and therapeutic models and highly complex factors concerning historical and developmental processes that have shaped the individual, family or group.
- To exercise autonomous professional responsibility for the assessment, treatment, and discharge of clients whose problems are managed by psychologically based care plans.
- To provide specialist psychological advice, guidance and consultation to other professionals contributing directly to clients' formulation, diagnosis and treatment plan.
- To ensure that all members of the treating team have access to a
 psychologically based framework for understanding and care of clients of the
 service, through the provision of advice and consultation and the
 dissemination of psychological research and theory.
- To undertake risk assessment and risk management for individual clients and to provide general advice to other professionals on psychological aspects of risk assessment and risk management, including responsibilities within the policies and clinical duties to safeguarding vulnerable adults and children.
- To communicate in a highly skilled and sensitive manner, complex information concerning the assessment, formulation and treatment plans of clients under their care and to monitor and evaluate progress during the course of both uni- and multi-disciplinary care. This will require being able to convey this to clients, families and colleagues with a range of understanding and knowledge so will require the ability to be flexible, adaptive and simple but yet retain a sophisticated understanding and approach.
- To provide expertise, advice, and support to facilitate the effective and appropriate provision of psychological care by all members of the treatment team.

Responsibilities for team or service functioning:

 To provide specialist psychological advice, supervision, guidance, and consultation to other professionals contributing directly to the formulation and treatment plans of individual patients: including advice on psychological aspects of risk and in the use of objective/standardized measures.



- To ensure a psychologically informed framework for ICMP Mental Health Service. Ensure that all members of the multidisciplinary team have access to a psychologically based framework for the understanding and careof service users referred to the service through the provision of advice and consultation. This includes ensuring that a psychological perspective is provided in a wide range of settings where service user care is discussed, planned and organized.
- Be responsible for the systematic governance of psychological practice within the ICMP Mental Health Service.
- To contribute to developing the service's delivery of accessible and acceptable services to diverse local communities
- To support the development of culturally competent services
- To advise other members of the service on specialist psychological care for clients
- To liaise with referrers GPs and other professionals concerned with clients in order to develop and review or contribution care plans
- To utilize theory, evidence-based literature and research to support evidencebased practice in individual work and work with other team members.

Teaching, training, and supervision:

- To contribute to the development of the knowledge and skills base within the ICMP Mental Health Service by maintaining an active awareness of current developments in psychology and psychosis and by implementing knowledge gained in practice.
- To provide clinical placements for trainee clinical and/or counselling psychologists/CBT therapists, ensuring that trainees acquire the necessary skills, competencies, and experience to contribute effectively to good mental health care and to contribute to the assessment and evaluation of such competencies.
- To provide post-qualification training (CPD) and clinical professional supervision to qualified clinical and/or counselling psychologists/CBT therapists attached to the service.
- To provide advice, consultation and training and clinical supervision to other members of the service for their provision of psychologically based interventions to help improve clients' functioning.
- To provide pre- and post-qualification teaching of clinical and/or counselling psychology/CBT as appropriate.
- To receive regular clinical supervision from an appropriately qualified clinician in accordance with professional registration requirements.
- To maintain and develop skills in the area of professional pre- and post-



graduate training and clinical supervision.

• To provide advice, consultation and training to staff working with the client group across a range of agencies and settings, where appropriate.
