Job Summary

This post is within Stroke at the Denmark Hill site. The post holder will provide Speech and Language Therapy services across this specialist clinical area 4 days per week. This post will require the post holder to work every other weekend (2/4 weekends per month) unless otherwise agreed. The post holder will be supported to develop a wide knowledge base and range of skills within adult stroke population. Line management will be provided by the Clinical Lead Speech and Language Therapist for Stroke.

Key Working Relationships

The post holder will establish, build and maintain working relationships within Speech and Language Therapy (cross-site) and all multidisciplinary teams within the relevant specialty.



Main Duties and Responsibilities

Clinical Responsibilities

- To manage an autonomous caseload on the stroke unit, which will include assessment, contribution to differential diagnosis, and specialist Speech and Language Therapy management for patients with acute, acquired communication and swallowing disorders, following King's College Hospital (KCH) Speech and Language Therapy evidence-based guidelines and abiding by KCH service standards.
- To participate in the management of patients with tracheostomies as part of the 7 day service in accordance with KCH multidisciplinary Tracheostomy Trust Guidelines and provide feedback for the tracheostomy ward round weekly as required.
- To identify barriers to effective communication within the environment and suggest and implement solutions where feasible.
- To provide specialist communication education and support to patients' families and friends, including communication partner training.
- To introduce low and high tech communication aids as appropriate and train the patient, their family and friends and the staff on using alternative and augmentative (AAC) communication aid systems or to refer on to the local communication aid specialist.
- To co-ordinate and promote communication developments under the guidance of a senior therapist e.g. mental capacity act issues, developing and delivering training on supporting communication, advising on environmental changes that support those with communication difficulties.
- To maintain and develop the use of AAC techniques and equipment across the team.
- To discuss, advise and plan appropriate patient goals with clients, carers and the multidisciplinary teams.
- To act as a key worker where appropriate.
- To provide complex and sensitive clinical information to patients and carers in clear, accessible and empathetic format, both in written and verbal form.
- To work as part of the multidisciplinary team negotiating appropriate therapy packages, length of stay and discharge arrangements.
- To attend ward rounds and multidisciplinary team meetings as appropriate.



- To liaise on a regular basis with relevant hospital and community therapy teams.
- To liaise with other agencies to ensure appropriate follow up and care arrangements for patients.
- To contribute to the Videofluoroscopy Clinic at King's College Hospital, providing general organisational cover where necessary.
- To develop and deliver training regarding communication and swallowing to carers, relatives and staff.

Administrative Responsibilities

- To maintain full, accurate and contemporaneous records within Epic.
- To provide timely and accurate reports including transfer and discharge reports.
- To prepare for and participate in an annual job appraisal which includes a 6 monthly review with the Speech and Language Therapy clinical lead.
- To attend King's College Hospital Speech and Language Therapy team meetings.
- To understand The Sentinel Stroke National Audit Programme (SSNAP) and the role of the Speech and Language Therapy team in capturing accurate data.
- To provide full, accurate and timely statistical data in accordance with SSNAP guidelines.

Leadership

To provide clinical support and advice to junior therapists within the team.

Education and Training

- To participate in the Dysphagia Trained Nurse programme run by the Speech and Language Therapy department.
- To take part in the clinical training for Speech and Language Therapy students as agreed and appropriate including preparation for and participation in practical exams.
- To participate in the Speech and Language Therapy Department in-service training programme.
- To pursue an active programme of continuing professional development including feedback to the team on any courses or conferences attended.



Governance / Quality Control

- To maintain and record an active programme of continuing professional development, including feeding back to colleagues on any courses or conferences attended.
- To make recommendations on service development and governance.
- To be an active member of relevant special interest groups.
- To participate regularly in the evaluation of the effectiveness of intervention and models of service delivery, maintaining up to date knowledge of relevant clinical practice and research.
- To undertake specific departmental audit projects and contribute to departmental research where appropriate.

Research and Service Development

- To participate in relevant audit activity within King's College Hospital NHS Foundation Trust.
- To participate in research initiatives in the relevant area.
- To publish and disseminate information which results from research and audit activity.

People Management and Performance

- Lead, coach and manage the performance of the team in line with good people management practices. Ensuring excellence is recognised and underperformance is addressed.
- Participate in regular performance appraisal meetings and ensure each member of the team has a clear set of objectives and development plans.
- Ensure the team is compliance with all statutory, mandatory training together with any professional training requirements, ensuring they are up to date and fully compliant.
- Manage team absences including sickness in line with Trust policy ensuring the appropriate return to work meetings occur, e-roster is updated and productivity is at keep to the highest possible level.
